1. Education: higher education in chemistry (Master of Science in chemistry).

Professional experience: experience in organic synthesis, preferably in bioorganic chemistry, knowledge of experimental techniques used in organic synthesis, knowledge of instrumental analysis methods to analyze chemical compounds, planning and conducting organic synthesis, analysis, and elaboration of obtained results.
3. Professional skills: the ability to search information from chemical literature, ability to use chemical software, ability to present results in public, organizational skills, fluency in spoken and written English
4. Personal predispositions: creativity in solving research problems, responsibility, ability to work in a team, enthusiasm, high motivation to expand knowledge, communicativeness.
